*2. On the basis of the scrutiny of the documents submitted by the institution and Visiting Team Report, the **Southern Regional Committee, NCTE** is satisfied that the above institution has adequate infrastructural, instructional and financial resources as per NCTE Regulations, 2014 (as amended from time to time) and decided to issue Letter of Intent prior to grant of recognition for **Integrated Teacher Education Programme (ITEP)** under clause 7(13) of NCTE Regulations, 2014.*

3. Before grant of Formal Recognition, you are required to submit the following documents through online mode within the stipulated period of 60 days from the date of issue of this Letter of Intent: -

- i. The institution shall submit the list of faculties having required qualification as per NCTE Regulations 2014 for the proposed course duly approved by the concerned affiliating body.*
- ii. The institution shall launch its own website with hyperlink to the NCTE website uploading the required information / documents as per clause 7(14) of the NCTE Regulations 2014 as amended time to time and furnish the evidence in this regard.*

iii. The institution shall maintain the required endowment and reserve fund converted in the joint operation in the name of institution and regional Director of the concerned Regional Committee as per clause 7(16) of NCTE Regulations 2014.

*4. Further, admissions shall not be made until Recognition Order under Regulations 7(16) of the NCTE (Recognition Norms and Procedure) Regulations, 2014 is issued by the **Southern Regional Committee**, NCTE and thereafter obtaining the affiliation from the concerned affiliating body.*

5. The SRC further decided that due to less built up area, the institution be permitted for only one unit of ITEP Programme. The institution be directed to opt for any one of the three Programmes applied for.
