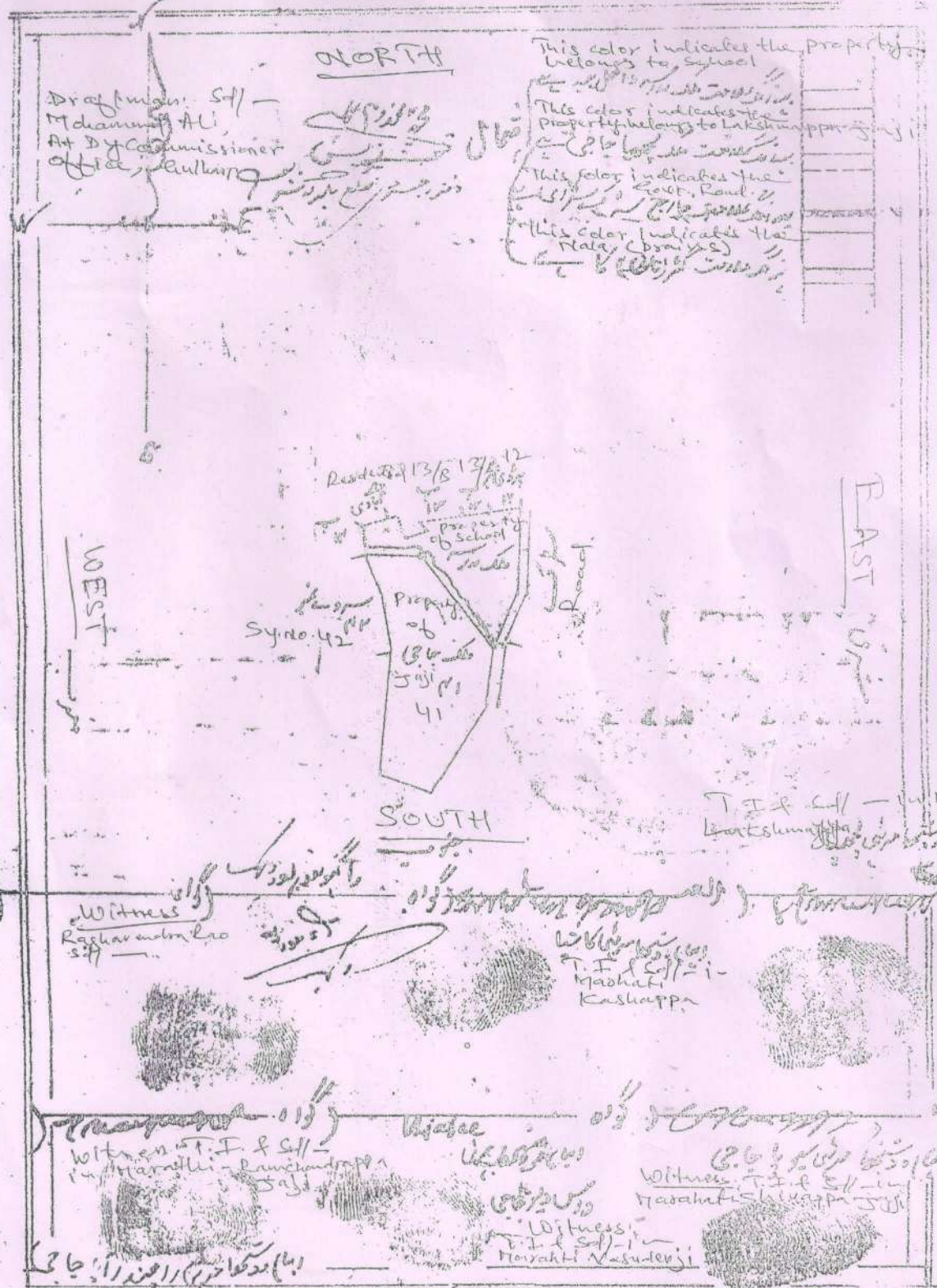

GIFT DEED

We, LAKSHMAYYA AND KASHAPPA both sons of PARSHURAM JAJI, residing at Mohalla Maqdoompura, Gulbarga do hereby execute this Gift Deed to this effect that, the School Nutan Vidyalaya Gulbarga which is run under the Nutan Vidyalaya Society, Gulbarga has been serving the public providing good education, therefore impressed with this social cause for upliftment of the whole society, a portion land to the extent of 06 (Six) Acres valued about Rs.1,000/- out of our total land in Sy.No.41 measuring 10 Acres 11 Guntas with R.A. Rs.23.00 situated at Bahamanipura Gulbarga which is adjacent to Nutan Vidyalaya School. This Patta land is in the name of our family widow Late Mrs.Yankamma w/o Sangappa. We, the two brothers being the family head, with our full cheers and with the consent of other family and business members (who have affixed their signatures herein below) have donated in favour of the said Nutan Vidyalaya School very long before. Therefore, Pandit Gopal Rao sab, the President of Nutan Vidyalaya Society has accepted the said gift. Since the date of Gift i.e. about last 11 or 12 years the above said Donee has been in occupancy and possession of the Gifted portion land and has been utilising as a Playground of their School. Further, we herewith declare that, all the ownership and possession rights of the said portion land under gift have been delivered in favour of the said Donee. The Revenue Tax of the said Gifted portion land has been determined to Rs.15 & Paise 11 by the Land Revenue Dept. which has to be paid by the said Donee every year regularly. By virtue of this Gift Deed, the School Society is at liberty to mutate the said portion land in their name and they can utilize the same as per their will and wishes for school purpose in which we or any of our heirs have no any objection, rights or claim whatsoever. Our names be in memory records of the said school for this Gift. Hence, these few sentences are reduced into writing as per Gift Deed with our sound mind and consciousness are true and correct.

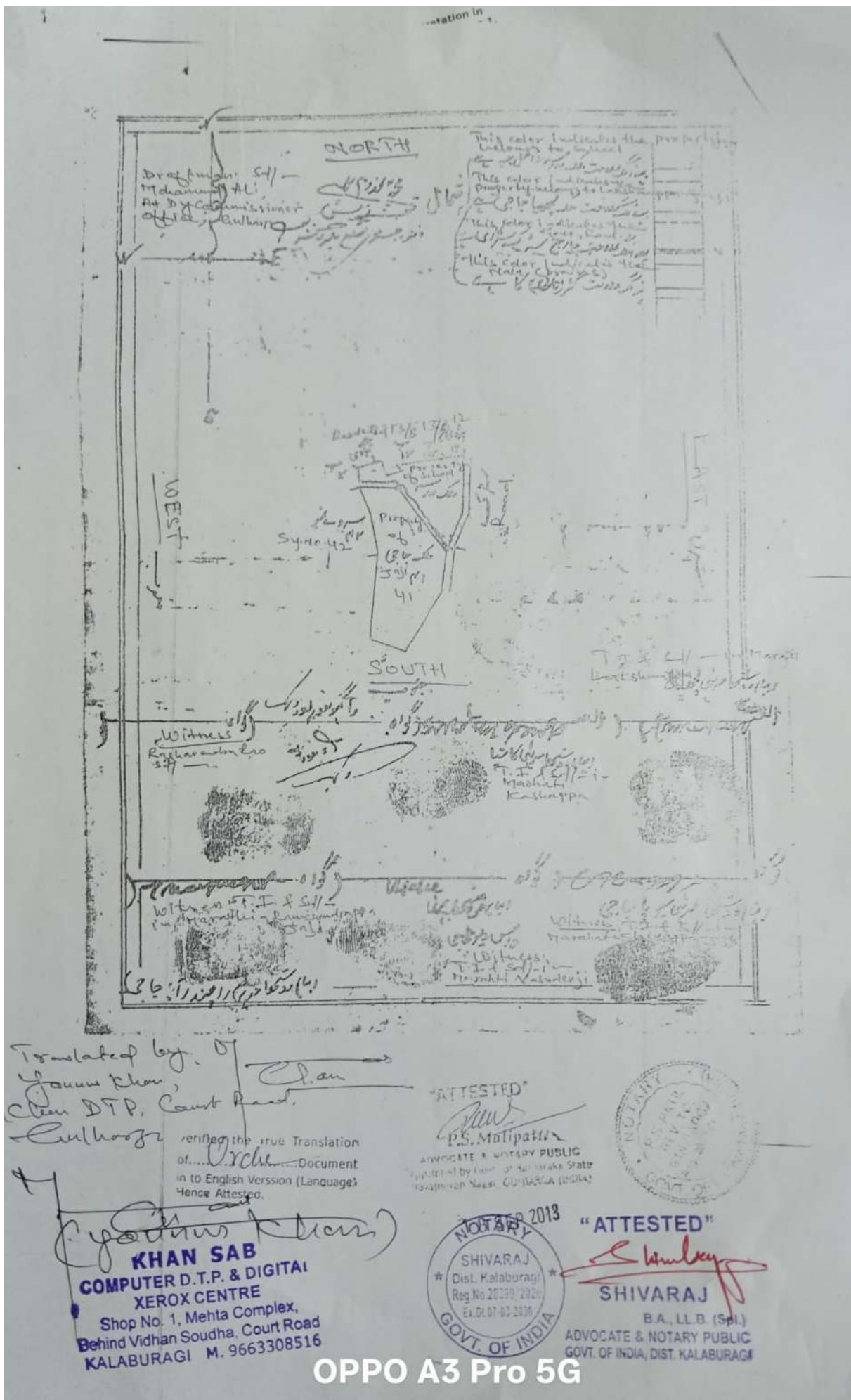
