- The institution shall launch its own website with hyperlink to the NCTE website uploading the required information / documents as per clause 7(14) of the NCTE Regulations 2014 as amended time to time and furnish the evidence in this regard.
- The institution shall maintain the required endowment and reserve fund converted in the joint operation in the name of institution and regional Director of the concerned Regional Committee as per clause 7(16) of NCTE Regulations 2014.

4. Further, admissions shall not be made until Recognition Order under Regulations 7(16) of the NCTE (Recognition Norms and Procedure) Regulations, 2014 is issued by the Southern Regional Committee, NCTE and thereafter obtaining the affiliation from the concerned affiliating body.
